Criminal Record Check

This check is intended for applicants who are involved as a volunteer, employee or in any situation where a **BASIC** Criminal Record Check is requested (e.g. retail or immigration). This check is NOT intended for applicants who are seeking volunteer and/or employment with vulnerable persons.

The search will include:

- Criminal convictions from CPIC and/or local databases
- Summary convictions (previous 5 years) when identified
- Findings of guilt under the Youth Criminal Justice Act within the applicable disclosure period**
 - ** Note: Youth records will only be provided to agencies that fall under Sec 199(o) of the YCJA (i.e. Federal, Provincial or Municipal government agencies)

Criminal Record and Judicial Matters Check

This check is intended for applicants who are involved as a volunteer, employee or in any situation where a **COMPREHENSIVE** Criminal Record Check is requested. This check is NOT intended for applicants seeking to work or volunteer directly with vulnerable persons.

The search will include:

- Criminal convictions from CPIC and/or local databases
- Summary convictions (previous 5 years) when identified
- Outstanding entries, such as charges and warrants, judicial orders, peace bonds, probation and prohibition orders
- Absolute and Conditional Discharges (for 1 or 3 years after the finding of guilt respectively)
- Findings of guilt under the Youth Criminal Justice Act within the applicable disclosure period**
 - ** Note: Youth records will only be provided to agencies that fall under Sec 199(o) of the YCJA (i.e. Federal, Provincial or Municipal government agencies)
